- **Applications Due:** Friday, October 1
- **Booth Fee (6' x 10'):** \$80
- **Table Rental Fee:** \$10
- **Booth Setup:** Friday, November 19, 2021 1 pm-5 pm.
- **Holiday Artisan Market:** Saturday November 20, 2021 9 am-4 pm.
- **Tear Down:** Saturday, November 20, 4:00 pm – 6:00 pm

#### **Rules and Criteria**

- Participants must be 18 and over (or accompanied by a parent/parent signs form) and from Michigan.
- The Holiday Artisan Market is juried to ensure that all items for sale are original and handcrafted by the artist selling their work. A limited amount of direct sales vendors will be permitted.
- Artisans/crafters must maintain proof in their booth area of all required licenses and inspections pertinent to the sale of their goods. Goods must be labeled according to specified standards (liability insurance, cottage food laws, health department permit).
- It is the sole responsibility of vendors that all Michigan sales tax be collected and paid to the Michigan Department of Treasury.
- Acceptance of an exhibitor is determined by the Artisan Market Jury, which includes City Staff.
- The Grand Haven Community Center does not provide guaranteed exclusivity to any exhibitor.
- Exhibitor booth size is 6' x 10'
- 6 ft. rectangular tables are available to rent for an additional \$10
- Photos provided or taken by the City of Grand Haven may be used for advertising and promotional purposes (news releases, website, facebook, etc.)
