Seasonal Slip Lottery**

A lottery system will be used to obtain a Seasonal Slip at the Grand Haven Municipal Marina for the 2024 boating season.

There are seven slips available.

**Occupancy Dates
May 8, 2024-October 9, 2024**

To enter into the lottery a person must complete the attached form. Entries will be taken by mail or can be hand delivered to the City Clerk during normal business hours. Each entry will be date stamped and assigned a ticket#.

The lottery drawing will take place on **September 13, 2023 at 10 am** at City Hall. Slips will be assigned in the order they are called, based on residency and slip length. You will be notified by phone of your slip assignment and will be given 48 hours to make payment and provide liability insurance.

The lottery will be held Wednesday, September 13 at 10:00 am

LOTTERY RULES:

1. One application per household
2. Valid entries require the submission of a formal application
3. Applications will be accepted through **September 12, 2023 until 5 pm**
4. If selected, applicants must submit a down-payment of \$500 within 48 hours of notification
5. If selected, the applicant will be required to sign a lease agreement and provide a certificate of liability insurance, naming the City of Grand Haven as additional insured in the amount of \$1,000,000. This requires action at a City Council meeting.
