# CITY OF GRAND HAVEN HISTORIC CONSERVATION DISTRICT COMMISSION REGULAR MEETING MINUTES

## WEDNESDAY, JANUARY 18, 2023 AT 5:00 PM

The meeting was called to order by Chair Liza Dora at 5:00 p.m. in the Council Chambers of City Hall.

Members Absent: Vice-Chair Erik Bye, (excused) and Member Chad Fisk, (excused).

## 1) General Business Call to Viewing Audience

A general business call to the viewing audience was made; there was no response.

#### 2) Approval of the Regular Meeting Minutes

Motion by Commission Member **Vandenberg**, seconded by Commission Member **Qua**, to approve the November 16, 2022, regular meeting minutes. This motion carried unanimously.

#### 3) Planning Commission Site Plan Reviews

There were no new plans for review/comment at this time; however, Member Qua informed the commission that there would be a site plan review next Wednesday, January 25 on the Diesel Plant. Although it is not in an historic district, it has been deemed historically significant by the commission when reviewed in 2020-2022 and the commission also hosted a public tour of the plant. The developer was extended 60 days of due diligence by City Council.

Chair Dora reported that the garage structure at 300 Washington Ave. was approved by the Planning Commission with a one-foot setback. Her concern was that the structure would look like a storage unit.

Member Vandenberg reported that she thought three of the eight total units at 300 Washington Avenue had been sold.

Planner Urquhart reported that the building permit application was updated to encourage people within historic districts to learn about the history of their structure and property. Administrative Liaison Angel suggested adding a hyperlink to the application for the historic conservation district map, so that applicants could easily determine if they are within an historic conservation district.

The owner of 509 Washington, which was built in 1868, reached out to Planner Urquhart to find out if there were any historical repair grants. Chair Dora recalled that Ben Tabor, owner of The Grand Armory Brewery, approached the commission (October 21, 2021) for support while they were seeking a State Historic Building Grant to offset costs for improvements. The commission wrote a letter of support.
