Chair Dora commented that City Council approved a resolution to release a request for proposals (RFP) for the purchase and development of the historic police and fire barn, which is city-owned property located at 18 N 5th Street. Administrative Liaison Angel shared the RFP that was posted on the City's web site earlier today and is due August 23. She clarified that the building is included in the Grand Haven Central Business District National Register of Historic Places Application and that the Police and Fire Department, 20 N 5th, is a "Contributing Resource," Section 8 Government. She noted that, although City Hall is a local landmark, 20 N. 5th is not. She also noted that City Manager Latsch would like to receive input from members of the
