1) General Business Call to Viewing Audience

A general business call to the viewing audience was made; there were no members of the audience present.

2) Planning Commission Site Plan Reviews

There were no new plans for review. Phase III was approved for 300 Washington Ave condos. Phase II approved floors 2, 3 and 4 added to the back of the building. There will be 17 total condos including the garage condos, plus a smaller, commercial building facing Washington Avenue.

The amended RFP for 18-20 N. Fifth Street, the Historical Grand Haven Police and Fire Department Building is advertised on the City's Web site. Bids are due for submission by October 9, 2023, to the attention of City Manager Latsch. She has not yet received any proposals as of today, but it is not uncommon for submissions to arrive on the date they are due.

3) Approval of the Regular Meeting Minutes

Motion by Commission Member **Bye**, seconded by Commission Member **Fisk**, to approve the Special Meeting Minutes of August 2, 2023, and regular meeting minutes and August 16, 2023. This motion carried unanimously.

4) Annual Election of Chairperson, Vice-Chair, Secretary.

All city boards and commissions shall annually elect a presiding officer no later than the end of September.

Motion by Commission Member **Vandenberg**, seconded by Commission Member **Bye**, to nominate and re-elect Member Liza Dora as chair; Erik Bye as vice-chair, and Linda Rosema as Secretary (to collaborate with Wendy Knoth). This motion carried unanimously.

5) Tri-Cities Museum Advisory Member Update

Kate Crosby, Tri-Cities Museum Advisory Member, reported that the Play Ball Exhibit's last day will be Sunday, September 24. The Haunted Museum Event will be held on Saturday, October 28, from 1:00 to 4:00 p.m. Costumes are encouraged and there will be a mini Halloween exhibit.
