Resolution Reaffirming the City of Grand Haven's DEI Values

WHEREAS the Diversity Statement of the City of Grand Haven states:

The City of Grand Haven respects, values and celebrates the unique attributes, characteristics and perspectives that make people who they are. The pillars of equity, diversity and inclusion are vital to a vibrant community, and we believe that bringing diverse individuals together and encouraging all voices to be heard allows us to build a stronger community. The City of Grand Haven upholds these pillars as crucial to healthy people and a healthy community;

And, **WHEREAS** the City of Grand Haven was fully supportive of the establishment of a Department of Diversity, Equity and Inclusion (DEI) in Ottawa County; and, once the DEI Office was opened, worked with it to deploy resources at the community level—resources that helped our City employees and citizen volunteers to understand differences and bridge divides among people;

And **WHEREAS** the Ottawa County DEI Department was eliminated by majority vote of the Ottawa County Board of Commissioners on January 3, 2023;

While we regret the loss of these resources and our partnership with Ottawa County in this important work, the City of Grand Haven reaffirms the tenets of its Diversity Statement and its commitment to making our City a welcoming, inclusive, and accessible community for all.
